On a motion by Trustee Perfetti seconded by Trustee DeMento and carried, to go into Executive Session at 6:14 p.m. to discuss contract negotiations. All ayes.

EXECUTIVE SESSION

On a motion by Trustee DeMento seconded by Vice Chairman Cocca and carried, to reconvene the meeting at 6:24 p.m. All ayes.

Chairperson McNulty-Ryan stated that the next item is Consideration of adopting a resolution pertaining to GIPA withdrawing from the New York Municipal Power Agency.

The proposed resolution reads as follows:

BE IT RESOLVED, that the Green Island Power Authority (the Authority) hereby wishes to withdraw its membership with the New York Municipal Power Agency (the Agency), and

BE IT FURTHER RESOLVED, that the Board of Trustees of the Green Island Power Authority hereby authorizes the GIPA Chief Executive Officer to notify the New York Municipal Power Agency, pursuant to Article I, Section 2 of the By-Laws and Articles III and X of the Agency Agreement, that it is withdrawing from membership in the Agency.

This resolution shall take effect immediately.

On a motion by Trustee Perfetti seconded Vice Chairman Cocca and carried, to adopt the resolution pertaining to GIPA withdrawing from the New York Municipal Power Agency. All ayes.

Chairperson McNulty-Ryan stated that the next item is consideration of Task Orders No. 9 and No. 10 as submitted by Albany Engineering. Task Order No. 9 is all of the stuff that Albany Engineering has been doing since we purchased the power plant; we just never really put it on paper. Task Order No. 10 is talking about entering into negotiations to possibly have them help us expand our power plant which we have the license to do now.

On a motion by Vice Chairman Cocca seconded by Trustee Perfetti and carried, to authorize the Chairperson to sign Task Order No. 9 and Task Order No. 10 as submitted by Albany Engineering. All ayes.

Chairperson McNulty-Ryan stated that the next item "Consideration of deeming certain property as surplus and disposing of it" we would like to table until the next month, so if someone would like to make a motion.

On a motion by Vice Chairman Cocca seconded by Trustee Perfetti and carried, to table "Consideration of deeming certain property as surplus and disposing of it" until the next meeting. All ayes.
