### **NEWS FROM THE ASSESSOR**

<u>SENIOR CITIZENS (65 yrs. and older)</u> - There are exemptions available to those senior citizens that are or will be 65 during the year that they are filing for the exemption – 2017. The exemptions require that one of the owners meet the age requirement, and that the home is the primary residence.

New and renewal applications for the ENHANCED STAR EXEMPTION ON THE 2017 ROLL will be based on the applicant's 2015 income. The NEW INCOME LIMIT of \$86,000 will be based on the Adjusted Gross Income of the 2015 Income Tax Return.

The **Senior Citizen** exemption for County and/or Village tax purposes is available for those 65 and older with an annual income not to exceed \$37,400 for county purpose and \$14,700 for village purposes. This exemption is based on the **Total Gross Income for 2016**.

If you are eligible for the Senior Citizen Exemption you will automatically receive the Enhanced STAR. However, if you are eligible for the Enhanced STAR you may NOT be eligible for the Senior Citizen exemption. They are two (2) separate exemptions. Senior Citizens exemptions are filed at the Village Office with Maggie A. Alix.

<u>New Home Owners</u> — Due to recent law changes approved by the Governor and the NYS Legislature, the BASIC STAR program is being restructured. New York State has decided that the NYS Tax Department will administer any NEW STAR applications, taking the responsibility from your local assessor. <u>This change is retroactive to March 1, 2015.</u> If you have recently purchased your home and are eligible for the STAR benefit you MUST register with NYS Department of Tax and Finance either online at <a href="www.tax.ny.gov">www.tax.ny.gov</a> or by phone at (518) 457-2036.

ALL EXEMPTION APPLICATIONS MUST BE FILED BY MARCH 1, 2017. If you have any questions or would like to meet with Maggie it is highly advised that you call the Village Office to schedule an appointment, (518) 273-2201.

Her alertness made it possible for our police officers, with the help of surrounding departments, to catch a burglar red handed. If she had felt like some people do who "don't want to get involved," the burglar would have gotten away. Please help us keep an eye on our community and keep it safe. Our officers do a great job of patrolling, but they can't be everywhere. Be our eyes and call 911. Let's let the "bad guys" know they can't get away with anything in Green Island!

Last month we had a drug related incident in the restroom of one of the businesses in the strip mall on Lower Hudson Avenue. In the course of the arrest, two officers were exposed to a drug that sent them both to the hospital via ambulance. Fortunately they are OK - but it was scary. What scared me even more is what could have happened if the police hadn't been called and a young child went into the restroom after the drug user left and had the same exposure that the officers had. It was a real eye opener for all of us. Our Police Department set up a meeting with all the businesses and the school officials to do some awareness and preventative training. It was very well received and appreciated by all who attended. We realize that we need to get the word out to everyone, especially parents, about the dangers of even being near anyone who is using heroin. We are working on an informational meeting for all residents to attend. I will keep you posted when a date and time have been set. If it is before the next newsletter, we will get the word out via the village website, Facebook and our alert system. Many of us think we aren't in danger because we don't use the drugs, but you may be in danger just by using a public restroom! Please make an effort to attend once we get the meeting scheduled.

Some things have changed and you may need to take some action to keep or obtain your exemption. Please read it carefully and call Maggie Alix if you have any questions.
