#### PUBLIC HEARING

The Village of Green Island will hold a public hearing on Monday, March 20<sup>th</sup>, 2017 at 6:30 p.m., at the Green Island Municipal Center, 19 George Street, Green Island, NY.

The purpose of the public hearing is to consider Local Law No. 1 of 2017, a local law to override Tax Levy Limit set forth in General Municipal Law § 3 - C. The purpose of the proposed local law is to allow the Village of Green Island to adopt a budget for the fiscal year commencing June 1, 2017, that requires a real property tax levy in excess of the tax levy limit as defined by General Municipal Law § 3 - C.

All interested parties may appear and be heard.

Village Budget Hearing will be held on <u>Wednesday, April 5<sup>th</sup>, 2017</u> at 5:00 p.m. at the Green Island Municipal Center, 19 George Street, Green Island for the presentation of the Village Budgets for fiscal year 2017-2018.

#### **RECREATION NEWS**

**Summer Employment**: The Recreation Department is accepting applications for <u>summer employment</u>. Due to budget constraints, summer jobs will be extremely limited. A competitive interview process will be mandatory for all applicants. Applications are now available at the Village Office or with Mrs. Legault in the main office at Heatly School. All applications must be returned to the VILLAGE OFFICE on or before April 28<sup>th</sup>, no exceptions. Applicants must be 14 years old by July 1, 2017 to be eligible for employment.

The Recreation Department is partnering with the Green Island Senior Citizens to host a **Breakfast with the Easter Bunny.** The event will take place on Sunday, April 9<sup>th</sup>, 2017, from 8:30 a.m. to 11:30 a.m. at the Community Center, 5 George Street. The cost is \$9 for adults, \$5 for children 10 and under. Breakfast will consist of pancakes, eggs, bacon, sausage, fruit, juice, coffee and tea.
